

Dear colleagues:

As of November 19, 2020, after the deadline for submitting candidacies for the elections to the Board of Directors of SITCPLA, **postponed due to force majeure on October 2**, a single candidacy has been received.

The candidacy submitted to the Electoral Commission is the same one that was communicated to you on September 15, and continues to be headed by Laura Gil Rodríguez, from the Air Europa section, which continues to be the largest section in union members, therefore this section is entitled to head the union by statutes.

No other candidacy has been submitted, so **the Electoral Commission confirms the candidacy presented in a timely manner.**

We want to remember that the statutes of SITCPLA establish that the heads of each of the union sections are automatically part of the Board of Directors, so that the members of all the sections will be represented in the Board of Directors through their heads of sections.

We remind you that, according to the statutes, the mode of voting can be by mail, in person and by proxy, as we detail below:

- Personally: On election day, from 10 am to 6 pm, casting the vote in the ballot box established for this purpose at the union's registered office (C / Alaró, 3, bajo, Madrid), once the voter has been identified.
- By proxy: Providing the member representing the voting ballot, in a sealed envelope, and providing a photocopy of the D.N.I. of the person he represents. No voter may hold the representation of more than two members for this act.
- By mail. **In order to guarantee the correct custody of the vote by mail, the Electoral Commission has decided that they should be sent to a notary, who will keep them until the vote is scrutinized on December 9.** Therefore, affiliates should send their vote to the following address:

Soon you will receive at your address all the necessary documentation to vote by mail, which will include the instructions to do so, a voting envelope, a ballot, and a larger envelope with the printed notary's address, where you should send your vote. **DON'T FORGET TO INCLUDE A PHOTOCOPY OF YOUR ID IN THE ENVELOPE ADDRESSED TO THE NOTARY, BUT OUTSIDE THE VOTING ENVELOPE.**

Remember, **on December 9 you have an appointment with the polls at SITCPLA.** Your vote is decisive.
